

## **Regulations of events, events and concerts organized by 4BB**

### **I. General information**

1. The Regulations apply to the entire event area designated by the Organizer.
2. Admission to the event area is possible only upon presentation of a valid admission ticket with a visible barcode. The organizer reserves the right to check the ticket at any time during the event.
3. Each participant is obliged to comply with these regulations and the regulations of the facility where the event takes place.
4. The organizer is obliged to ensure order and safety at the event site. It is prohibited to bring into the event area: weapons, alcohol, dangerous objects and tools, explosives and pyrotechnics, narcotic drugs and psychoactive substances, poisonous and radioactive agents, flammable liquids, selfie sticks, tripods, umbrellas with sharp ends and other items that In the opinion of the organizer, they may pose a threat to other event participants. It is not allowed to bring drinks and food, except for people whose health condition requires a specialized diet confirmed by a medical certificate.
5. The organizer reserves the right not to admit or ask a person having the above-mentioned items from the event premises.
6. The use of professional photographic equipment, cameras or other audio-video recording equipment is permitted only by persons accredited for this purpose. Accreditations can be obtained by contacting the following e-mail address: [info@kpoptouring.com](mailto:info@kpoptouring.com)
7. The Organizer has the right to refuse to bring a camera, camcorder or other audio-video recording equipment to the Event area.
8. The Organizer has the right to record the course of the Event together with the images of the Event Participants using image and sound recording devices and to use these materials without the additional consent of the Participant.

### **II. Rules of participation**

1. Persons with motor and visual disabilities or other disorders that constitute a barrier to participation in the event are obliged to inform the Organizer about their participation in the event in order to guarantee proper visibility and safety during the Event.
2. Applications for participation of persons with disabilities should be made no later than 14 days before the planned date of the event, by e-mail to the following address: [bb@4bb.com.pl](mailto:bb@4bb.com.pl)
3. The organizer is not responsible for any inconvenience caused by failure to register or too late notification of participation in the event by persons with disabilities.
4. In Poland, a person who is over 16 years of age on the day of the event may participate in the event independently. In other countries, the facility's regulations or general laws must be followed.
5. In Poland, the written consent of a parent or legal guardian is required for the participation of persons who are over 16 years of age on the day of the event but are under 18 years of age. The consent should be downloaded from the link, completed, signed and presented in paper form to the event staff:

In other countries, the facility's regulations or general laws must be followed.

6. In Poland, persons under 16 years of age may participate in the event only if accompanied by a parent or legal guardian or accompanied by an adult with the consent of a legal guardian. The consent should be downloaded from the link, completed, signed and presented in paper form to the event staff:

In other countries, the facility's regulations or general laws must be followed.

7. The organizer has the right to ask people to leave the event if they disturb other participants in receiving the event, in particular people under the influence of alcohol, loud or aggressive people. These people lose the right to make complaints and claims against the Organizer.

8. The participant acknowledges that he or she stays at the event site at his or her own risk and responsibility.

### **III Bearer tickets**

1. By purchasing a ticket, the Participant accepts these Regulations and undertakes to comply with them.

2. The ticket is valid only with a visible barcode or QR code. The ticket can be printed or presented on an electronic device. Confirmation of payment or order does not constitute possession of a ticket and does not constitute a document confirming the possibility of participating in the event.

3. Return or exchange of tickets is possible only in the event of cancellation of the event or in the event of a significant change in the program, place or date.

4. Tickets can only be returned or exchanged at the place of purchase.

5. The organizer is not obliged to refund money for an unused ticket.

6. The organizer is not responsible for tickets purchased at unauthorized sales points or for tickets from the secondary market. The organizer warns that the resale of tickets at a profit is punishable by a fine, arrest or restriction of liberty (Article 133 of the Criminal Code in Poland).

7. The Organizer does not consent to the resale of tickets at the concert venue, especially if the Organizer runs an official ticket sales point.

### **III A Personal Tickets (in Poland)**

1. In the case of Personal Tickets, the Organizer reserves the right to verify the data contained on the Personal Ticket with the data of the holder of this Ticket. The Organizer reserves that if the data contained in the Ticket differs from the data of the Ticket holder, it has the right to refuse such person's participation in the Event for which the Ticket was purchased.

2. The possibility of changing the data on personalized tickets depends on the event. Information about whether the data can be changed or not will be posted on the website of the authorized ticket office

in the description of a given event and/or during the purchasing process and/or the ticket office's regulations.

3. If the Organizer agrees to change the data of the holder of a personal ticket, the person transferring and the person taking over the ticket is obliged to present a statement (original) confirming the change of personal data on the ticket before entering the event area.

In other countries, the venue's regulations or the ticket seller's regulations must be followed.

#### **IV Special epidemic safety rules**

1. Each Participant declares that if on the day of the event he/she is subject to quarantine or sanitary supervision for safety reasons, he/she will not take part in the event.

2. Each Participant declares that if, in the last 14 days before participating in the event, he/she had direct contact with a person with confirmed COVID-19 infection, a person subject to quarantine or isolation due to COVID-19, a person who had visible symptoms of illness, or has been exposed to contact with an infected person for safety reasons, will not participate in the event.

3. Each Participant declares that if he/she has symptoms of illness in the last 14 days before participating in the event, he/she will not take part in the Event for safety reasons.

4. The number of people unvaccinated against the SARS-COV-2 virus who can participate in the event depends on the epidemiological regulations in force on the day of the event. If it is necessary to present a declaration of vaccination status against the SARS-COV-2 virus, detailed instructions will be provided to Participants by e-mail or by information or security services at the mass event.

5. The Ticket Buyer declares that he has informed the holders about the content of the above declarations and that the Ticket holders have submitted them on their behalf through him.

6. If it is detected that a person infected with the SARS-COV-2 virus took part in the event, the Participant consents to the ticket distributor being the administrator of the Participants' personal data making their personal data available to the Chief Sanitary Inspectorate and law enforcement services.

7. People participating in the event are obliged to follow the recommendations of the Organizer's representatives aimed at ensuring safety and order.

8. At the event site, epidemiological regulations in force on the day of the event must be complied with.

9. Epidemic safety rules may change depending on the epidemiological regulations in force on the day of the Event.

#### **V Final provisions**

1. In matters not regulated by these regulations, the provisions of the Civil Code shall apply.

2. In matters not regulated by these regulations, final decisions on organizational and orderly matters rest with the authorized representatives of the organizer.

3. In other countries, the venue's regulations, general laws or the ticket seller's regulations must be followed.
